

BETACARE DROUGHT

NUMBER OF BETAPOINTS REQUIRED: 1,500

Conditions for obtaining the "BetaCare DROUGHT" reward and the drought discount of £45 as part of the "BetaPoint" service and reward programme of Betaseed GmbH.

The following provisions regulate the conditions for obtaining the "BetaCare DROUGHT" reward (hereinafter referred to as the "reward") and the conditions for obtaining a drought discount of £45 as part of the "BetaPoint" service and reward programme of Betaseed GmbH (hereinafter referred to as "Betaseed").

1. Receiving the reward

1.1 Only registered participants in the "BetaPoint" service and reward programme of Betaseed GmbH (hereinafter referred to as "participant(s)") can receive the "BetaCare DROUGHT" reward.

1.2 To order the reward, a participant must redeem 1,500 BetaPoints accumulated in their BetaPoint account for the reward in the BetaPoint rewards shop.

2. Limited availability of the reward

2.1 The number of rewards that a participant can exchange for 1,500 BetaPoints is exclusively limited by the number of BetaPoints in the participant's account. A participant can therefore exchange 1,500 BetaPoints for the reward several times. Example: If a participant has 6,000 BetaPoints in their account, they will be able to order the reward 4 times.

3. Limited period for exchanging 1,500 BetaPoints for the reward

The period during which a participant can exchange 1,500 BetaPoints for the reward is limited and only possible during the period from 1 March 2025 to 31 May 2025 (24:00).

4. Description of the reward

Participants who have ordered the reward by redeeming their BetaPoints will, if the conditions set out

below in point 5 ("Conditions for obtaining the drought discount") are met, receive a drought discount of £45 (hereinafter referred to as the "drought discount") from Betaseed for each reward they have ordered.

5. Conditions for obtaining the drought rebate

5.1. To receive the drought discount for a reward ordered, the following two conditions must be met:

5.1.1 When redeeming 1,500 BetaPoints for a reward, the participant selected one of the following weather stations of the Met Office. The participant chooses, from the weather stations listed below, the one that is closest to his farm on which he grows the Betaseed sugar beet seed purchased.

Weather station	Cumulative rainfall over July-August - 20-year average (in mm)	Thresholds in mm

WADDINGTON	121.0	85.1
MARHAM	125.7	89.5

5.1.2 The amount of precipitation measured during the period from 1 July 2025 to 31 August 2025 (hereinafter referred to as the "defined period") from the meteorological station chosen by the participant in accordance with paragraph 5.1.1 must remain below the threshold indicated in paragraph 5.1.1 of the table for the meteorological station chosen by the participant.

5.1.3 If either or both of the conditions set out in paragraphs 5.1.1 and 5.1.2 are not met, the participant will not receive the drought rebate for the rewards ordered and the reward will be cancelled, with nothing else replacing it.

6. Availability of meteorological data

6.1 To determine the amount of precipitation measured by one of the meteorological stations referred to in point 5.1.1 during the specified period, and therefore to determine whether the threshold referred to in point 5.1.1 has not been reached for the meteorological station in question, only the data as measured by

the Met Office at this meteorological station in question will be decisive. Data relating to the measured amount of precipitation will be collected by Betaseed from the portal of the Met Office.

6.2 If the amount of precipitation measured by the Met Office during the specified period at one, several or all of the meteorological stations referred to in paragraph 5.1.1 are not available to Betaseed for any reason whatsoever, Betaseed reserves the right to fall back on the amount of precipitation measured by another meteorological station of the Met Office, which station is located at a maximum distance of 20 km from the meteorological station for which no measurement of the amount of precipitation is available (hereinafter referred to as the "substitute station"). The amount of precipitation measured by this substitute station will then be decisive in determining whether the indicated threshold has not been reached and whether the participant receives the drought discount.

6.3. If, for any reason, the precipitation measured during the defined period is not available at a substitute station during the period specified for Betaseed or objectively, Betaseed reserves the right to base itself on the precipitation measured at the Met Office weather station closest to the weather station mentioned in point 5.1.1 for which the measured precipitation is not available. The amount of precipitation measured at this weather station is then decisive in determining whether the threshold indicated has not been reached and whether the participant benefits from a drought discount.

6.4. If, for any reason, the precipitation measured in accordance with point 6.2. or point 6.3. is not available to Betaseed or objectively, Betaseed reserves the right to terminate the action. In this case, each participant will receive a refund of the BetaPoints he/she has redeemed on his/her user account.

7 Notification and transfer of drought rebate

7.1 All participants will be informed by Betaseed on the website or by e-mail, no later than 30 December 2025, of the amount of precipitation measured during the defined period at the weather station they have chosen and will be informed accordingly whether or not the conditions for payment of the drought rebate by Betaseed to the participant concerned have been met.

7.2 Participants for whom the conditions for payment of the drought rebate are met (hereinafter referred to as "entitled parties") will then be informed by Betaseed by e-mail of the drought rebate to which they

are entitled and will be asked to provide Betaseed with their bank details so that the drought rebate can be paid to them. Within one month of being informed by e-mail and having provided Betaseed with their bank details, Betaseed will pay the drought rebate to which they are entitled.

7.3 By transferring the drought rebate to which the beneficiary is entitled to the bank details indicated by him, Betaseed is released from its obligation to provide a service.

8 Final provisions

8.1 Unless explicitly stated otherwise above, the "Terms and Conditions for Participation in BetaPoint, the service and reward programme of Betaseed GmbH" available at www.betaseed.com/uk/en/BetaPoint/ shall apply in addition.

8.2 Betaseed reserves the right to modify and/or add to these conditions at any time.
